I'm working on a story about a string of thefts/identity theft related to something known as the Felony Lane Gang. The victim I've been speaking with is name Pamela Juers, and her purse was stolen from her car at the upper Thomas Jefferson Parkway lot back in May. Initially, the thieves used another victim's check to withdraw \$3,000 from her account, but even after she closed that

accounts, they were able to hit her again by using her license as ID to deposit another victim's check and make a withdrawal two months later.

I'm wondering if I might speak with an investigator or find out if these types of crimes have been occurring with more frequency in Albemarle County. I know the Henrico County PD has an ongoing investigation relating to Ms. Juers and the other victims as well.
